When asked about her husbands condition she stated that he went to Kenmore Mercy for treatment, that he was given an IV and antibiotics for the bite, was x-rayed for possible rotator cuff injury and that he sustained an interior orbit fracture to his eye. They did have discharge paperwork documenting the injuries.
- Mele also complained about a secong incident involving Maria Grisanti and her son on 6/23 in which a vehicle was parked improperly and Mele was given the finger by both Maria Grisanti and her son.
- Mele expressed disapproval over the fact that no arrest was made on the night of incident. I did explain to her that everything needed to be collected, investigated, and reviewed before any arrest/s would be made.
- Did speak with PO Gehr in regards to conduct of the Grisantis upon initial arrival on scene. Gehr did states that once on scene the females involved were still arguing and screaming at each other. Once parties were separated he attemted to speak with the Mele's. During conversation Maria Grisanti continued to yell and scream and did trie to approach. At that point it was decided that Maria Grisanti would be placed in the back of a patrol vehicle to try and calm the situation. A. Got home, we went to dinner at north end and then dairy queen, I was getting stuff out of the car. I said to my wife that they now have a relative blocking the driveway. I went inside and called D-District to see if it was possible to have someone come down and write a ticket. They said they couldn't do that and I had to call 911 . I called 911 and said it wasn't a big deal but there was a truck with NJ plates partially blocking the driveway. They said it was busy but would sent someone. They asked if I knew who it was and I said it was the neighbors but we aren't on speaking.terms but that they always block the driveways of mine and my neighbors. My wife took the dog outside and I was going to unload the car because we had gone to Aldi's as well. I go outside, my wife was probable a house down to the left, she came back to the house and she was standing by the truck. All of a sudden Gina, Joe and whoever owns the truck came out of the house and down toward the apron of their driveway and started yelling if we hadan F-ing problen about the way we parked. I told them that I had already called the police and that they may come give them a ticket. They could have just moved the car upa little. The girls started arguing so my wife started to walk towards them across the street. I went and tried to grab my wife and pull her back. Then the two girls grabbed her. Joe is an instigator and started yelling girl fight. I told him to get your wife in house. He pushed me, I pushed him back. It was like a Greco roman wrestling. We ended up in my driveway. During the fight he grabbed my shirt and pulled it over my head like they do in hockey. At the end he took a swing at me and he missed and was falling and while he was falling he grabbed my chain and my tee-shirt and ripped it off. Then it was over. It lasted like 2.3 minutes if that. The cops came and we went to our yard and they went to theirs. When the police came my wife was still screaming. The girls were screaming back and forth and the officers were trying to figure out what was going on. One officer went to the Mele side and one came to talk to us. My wife kept screaming so one of the Officers grabbed her
and pulled her away as if to cuff her. He tried to do a sweep motion and take her down and I told them that I got her. I respect police, my daughter and son-in-law are police.
Q. What are the names of your neighbors that were involved in the dispute?
A. Gina and Joe Mele, and I don't know who the girl was but she is from NJ from the plate on their car:
Q. During the initial verbal dispute what made you go across the street?
A. Because they came to the apron of their driveway and my wife was walking over towards them and then the girls ended up fighting.

## Good Evening Detective Moretti,

I just had a quick few items/requests that I wanted to send over to you in follow up to the above incident.

As mentioned on the night of the incident, I wish to make clear that my husband and I still wish to press assault charges against Mark and Maria Grisanti. As you know, Maria caused bodily injury to my husband which included a vicious bite to his arm which broke skin, a fractured bone under his eye, and a shoulder injury which all resulted in having to be seen in the emergency room. Due to my husband's health history of cancer and current autoimmune condition, my husband had to be given an IV of antibiotics and a prescription of antibiotics to avoid a serious infection that could have been caused by Maria Grisanti's saliva entering my husband's bloodstream. Also, in the time. of the global pandemic COVID-19 my husband was put in even more grave danger from this injury. I would think that charges would be more than reasonable including harassment, trespassing and assault. Per conversations with you and with D District, we are unable to do so and that the DA is investigating.

Per a previous phone conversation we had, I wanted to bring attention again to the possibility of additional footage that could have been captured by Mark Grisanti's Ring doorbell. I know I have been told that their free-trial ended but would like that to be further looked into and verified. Additionally, I wanted to remind you that the Chwalinski residence at also surveilled with cameras in two different front windows with clear view of my property so hopefully access to that footage will be avallable.

I also am concerned about the credibility of the witnesses who have made themselves available to you. As you mentioned, none of the witnesses whom you spoke with saw the entire incident. Additionally, these witnesses are close. friends of the Grisanti's and they all frequently socialize together and with their families, It seems that these accounts would inevitably be biased.

I have also grown frustrated with the lack of clear communication and being bounced back and forth between BPD and the District's Attorney's office. I have requested copies of the statements from the incident. I was told by BPD that the DA's office would have no problem providing them to me; however, when I called the DA's office and spoke with Danielle D'Abate I was told otherwise. She stated that I could not have access to the statements, and went as far to say that she could not speak with me at all due to the pending investigation and said I had to ask BPD for the statements again. Do you have access to these statements? I would like copies at your soonest convenience.

In conclusion to the above mentioned, I am really concerned that mind and my husband's civil rights are being violated. I know that you have mentioned that you are "dealing with higher ups" and "man of power," but I would hope that
Mark Grisanti's position as a Judge would not be infringing upon our rights as we're entitled to equal protection under the law. As you can imagine, my frustration is growing with the run-around and lack of action and it is an overwhelming feeling of injustice.
